10:15 am -11:15 pm - Dittman v. UPMC- Pennsylvania joins the global trend toward increased protection for personal information

In the landmark Dittman v. UPMC case, the Pennsylvania Supreme Court held that **employers owe their employees a duty to exercise reasonable care when collecting and storing personal and financial information**. The Court also called into question the viability of the economic loss doctrine, which bars tort claims involving only pecuniary loss. Although Dittman involved employee data, future court decisions may impose a duty to exercise reasonable care when collecting and storing the personal information of customers, clients, students, and others. We will engage in a thorough discussion of this landmark case and give practical guidance on how to protect information, respond to data breaches, and avoid liability.
