Introduction

Additional Information for 2010 Sponsorship Benefits

In designing the 2010 Sponsorship Program, ACC Austin examined ways in which it could give Sponsors a package of benefits that would provide maximum visibility to our membership of the valuable support that ACC Austin gets from its Sponsors and would also increase the amount of time that our Sponsors meet and interact with our membership. These include:

1. **ACC Austin Annual Meeting and General Counsel Panel:** ACC Austin holds an annual reception for in-house counsel and Sponsors which has grown into a top networking event for in-house counsel. In addition, the event brings together a panel of 4-5 General Counsel from leading local companies and organizations that represent the diversity of ACC Austin membership in terms of type of industry, size of company, and size of department, for a roundtable discussion of how they got to the CLO seat, what the hot-button issues are on their desks, how they recruit, manage and motivate their staff, and what they want and need from their outside counsel. Both in-house and outside counsel value the insights provided. The reception is designed to maximize opportunities for networking and we believe that has been the key to its success. All sponsorship categories are provided tickets to this event.
2. **Educational / Social Programs:** ACC Austin provides CLE programs geared to the practice needs and interests of in-house counsel. From January through December of each year, we put on CLE programs which provide Texas Bar MCLE credit and which may be eligible for CLE credit outside of Texas as a benefit for our members who are members of the bars of various other states. We also provide programs that include smaller, informal networking opportunities. The Title, Platinum and Gold Levels include presenting a program/social for ACC Austin. The Silver level provides opportunities for Sponsors to be part of a program event.
3. **ACC Austin Web Page:** ACC Austin's Web page will include advertisements on the home page for certain categories of Sponsors. In addition, there will be a general "Sponsor" page that will list all Sponsors, with a link to the Sponsors' Web page. Website Main Page Sponsors will have an article on the main page for one month. The ACC Austin Chapter Sponsorship Committee and the Chapter Administrator will work closely with Sponsors to coordinate topics and placement for the articles.
4. **ACC Austin Newsletter:** Each quarter, ACC Austin publishes a newsletter, which is sent to all ACC Austin members. The Title Sponsor will have the opportunity to publish a four-page article in the newsletter (or two 2-page articles), while Platinum Sponsors will have the opportunity to publish a two-page article. The ACC Austin Chapter Sponsorship Committee and/or the Chapter Administrator will work closely with Sponsors to coordinate topics and placement of these articles. The newsletters will also be posted on the newsletter section of the ACC Austin Website. Based on a recent survey of our members, the newsletter, webpage and monthly e-updates are read by more than 80% of our membership on a regular basis.



5. **Pro Bono/Community Service Opportunities:** In our recent Member and Sponsor surveys, both our members and Sponsors indicated that they wanted more ways to get involved in the community. ACC Austin answered by developing a Pro Bono/Community Service Committee and adding a Pro Bono/Community Service Chair on our board. The Pro Bono/Community Service Committee works to bring relevant and meaningful opportunities to our members and Sponsors. Sponsors will be invited to participate in existing opportunities or they may have the option to exclusively Partner with our Chapter on an opportunity of particular interest. Pro Bono/Community Service events provide an opportunity for Sponsors and members to get to know each other in a non-traditional setting.

2010 Sponsorship Guidelines

1. **Term:** The term of a sponsorship under the 2010 Program is from January 1, 2010, through December 31, 2010. ACC Austin reserves the right to modify the sponsorship program at any time without notice.
2. **Sponsorship fee:** Sponsorship fees will be due in full within thirty (30) days of notification of the award. Sponsor benefits will not be available until payment of sponsorship fees in full has been received.
3. **Newsletter:** If the Sponsorship includes an article in the quarterly newsletter, ACC Austin will provide Sponsors with the applicable deadline and word-count at the time of notification of the award of the Sponsorship. ACC Austin will work with the Sponsor to develop a mutually agreeable topic for the article.
4. **Programs:**
 - a. If the Sponsorship includes presentation of a program, ACC Austin will work with the Sponsor to plan and present the selected program and will assist in identifying potential in-house panelist(s) to assist in the presentation.
 - b. ACC Austin will be responsible for marketing the sponsored programs and events to its members, via, newsletters, e-mail notices and its Web page. All Sponsors are also strongly encouraged to market the programs and events they are presenting for ACC Austin to their respective in-house clients.
 - c. In order to ensure that programs are marketed in a timely and effective manner, the ACC Austin Sponsorship Committee, Chapter Administrator or program coordinator will work closely with the Sponsor to ensure deadlines associated with the program requirements are met.
 - d. ACC Austin handles RSVPs for all programs and, if appropriate, collects all fees. Fees collected by ACC Austin remain the property of ACC Austin.
5. **Main Webpage Articles:** Bronze Sponsors are entitled to an article on the main page of the ACC Austin Website for a month. ACC Austin will provide Sponsors with the applicable deadline and word-count at the time of notification of the award of the Sponsorship. ACC Austin and Sponsor will develop a mutually agreeable topic for the article.
