

GDPR: Applicability

Processing the personal data of data subjects



GDPR: Applicability

The GDPR applies to:

 Entity that processes personal data as part of its activities in the EU, regardless of where the data is processed

or


- An entity established <u>outside the EU</u> that is either
 - offering goods/services (paid or for free)

or

-is monitoring the behavior of individuals in the EU

GDPR Enforcement

GDPR Maximum Penalty:

€20 million, or up to 4% of the annual worldwide turnover of the preceding financial year, whichever is greater.

Major GDPR fine count:

- 2020: 17

-2019:31

-2018:1

- Total: 49

Major GDPR fine totals:

- 2020: € 77,958,722

- 2019: € 440,515,407

- 2018: € 400,000

- Total: € 518,874,129



GDPR Enforcement

- Most frequent violations
 - Data access/subject requests: Insufficient response to data subject/insufficient transferability measures
 - Lawful processing: Insufficient legal basis for data processing; Non-compliance with general data processing principles
 - Data breach: Insufficient technical and organizational measures to ensure information security
 - Transparency
 - Data Minimization



GDPR Enforcement

- Google: €50 million (\$56 million)
 - Art. 6, Consent and transparency, prechecked consent on personalized advertising
- Marriot: \$99M Pounds
 - Data breach affecting 30M EU residents; insufficient technical and organizational measures to ensure information security
- PwC: €150,000 (\$165,400)
 - Art. 83, violation of fairness and transparency principles on data use of employees for commercial purposes
- Other Investigations: Facebook, Instagram, Twitter, Babst Calland LinkedIn, Verizon, Apple, etc.

California Consumer Privacy Act (CCPA)


CCPA: Applicability

Business that:

- -does business in the State of California,
- -collects personal information of California residents,
- alone or with others determines the purposes or means of processing of that data, <u>and</u>
- -satisfies one or more of the following:
 - (i) annual gross revenue in excess of \$25 million,
 - (ii) alone or in combination, annually buys, receives, sells, or shares the personal information of 50,000 or more consumers, households, or devices, or
 - (iii) derives 50% or more of its annual revenues from selling consumers' personal information.



CCPA: Key Elements



CCPA: Enforcement

- Attorney General regulations went into effect on August 14, 2020 and began enforcement on July 1, 2020
- Class Actions Filed under CCPA Private Right of Action (Zoom Case): a consumer's personal information "is subject to an unauthorized access and exfiltration, theft, or disclosure as a result of the business's violation of the duty to implement and maintain reasonable security procedures and practices." Cal. Civ. Code § 1798.150(a)(1)

- CA Privacy Rights Act (CPRA) On November Ballot
 - -Sensitive information
 - "Sale" Definition
 - Creation of enforcement agency: California Privacy
 Protection Agency




Personal Information Protection and Electronic Documents Act (PIPEDA)

PIPEDA: Applicability

- Business that
 - -collects, uses, or discloses
 - personal information of individuals residing in Canada
 - -in the course of commercial activities in Canada

U.S. Federal Landscape

- Privacy Act of 1974 Protects personal information maintained by federal agencies
- Health Insurance Portability and Accountability Act (HIPAA) /
 Health Information Technology for Economic and Clinical
 Health Act (HITECH) Protects personal health information
 (PHI)
- Gramm–Leach–Bliley Act (GLBA)— Protects financial information
- Children's Online Privacy Protection Act (COPPA) Protects children's privacy
- Family Educational Rights and Privacy Act (FERPA) —
 Protects students' personal information
- Fair Credit Reporting Act (FCRA) Governs the collection and use of consumer information



U.S. Federal Landscape

- FTC Enforcement Legal actions against organizations that have violated consumers' privacy rights, or misled them by failing to maintain security for sensitive consumer information, or caused substantial consumer injury.
 - Section 5 of the FTC Act, which bars unfair and deceptive acts and practices in or affecting commerce
 - Enforcement of other federal laws relating to consumers' privacy and security.

U.S. State Law Landscape

- Consumer Privacy
 - Illinois Biometric Privacy Act (BIPA)
 - -Nevada SB 220 (October 1, 2019)
 - Maine Act to Protect the Privacy of Online Customer Information (July 1, 2019)
 - Massachusetts Standards for the Protection of Personal Information of Residents of the Commonwealth (March 1, 2010)
 - New York Consumer Privacy Act (NYPA) (Pending)
- Data Breach Notification Laws


