### 2020 ACC-W Diversity Scholarship Recipients

ACC-W is proud to sponsor three diversity scholarships totaling \$9,000 (\$3,000 per scholarship) to first and second year law school students at select Washington State law schools. Scholarship recipients are determined from a number of criteria

Delaney Jacobson is a first year law student at Gonzaga University School of Law where she is a member of the Women's Law Caucus and the 1L Class Representative for the Gender and Sexuality Organization. Ms. Jacobson has shown a commitment to advocating for LGBTQ+ rights both within the legal community and her hometown, where after graduation, she established a LGBTQ+ Club at her high school and utilized social media to reach out to, and support LGBTQ+ youth connect with mentors and an online community designed to support them. Ms. Jacobson is also a volunteer with the Lavender Rights Project, assisting transgender individuals legally changing their names on government documents.

**Majidah Cochran** is a second year law student at **Seattle University School of Law** where she is the President of the Black Law Student Association, Secretary/Treasurer of the Health Law Society, and an Associate Editor of




capacity, and in community impact. Ms. Cochran's work focuses on the disparity of health care for people of color and the impact of the opioid crisis on Indigenous peoples. Ms. Cochran volunteers with Lavender Rights Project, assisting transgender individuals legally changing their names on government documents.

Devin Hogan is a first year law student at Seattle University School of Law where she is a Law School Admissions Fellow and serves as a member on the Alternative Disputes Resolution Board and Moot Court Board. She is also a member of the Veterans Law Society. Prior to law school, Ms. Hogan volunteered as a teacher assistant and tutor in Panamá, worked as a journalist reporting on the 2014 Gaza War both from Israel's and Palestine's perspectives, and worked as a trainer within the software industry, often as the only woman in the room. These experiences have impacted Ms. Hogan's

approach to diversity and are reflected in her approach to increasing diversity within the legal community through the work she does.

Mustafa Hassoun is a first year law student at University of Washington School of Law where he is a Gregoire Fellow, has a Foreign Language and Area Studies ("FLAS") fellowship in Persian, and is a Board Member for the Center for Human Rights and Justice. In 2016, Mr. Hassoun co-founded the Baraka English School in Baghdad, Iraq, an English language instruction program for orphans, which also provides students with basic care. When he completes his FLAS studies in Persian, he will be professionally proficient in four languages: Arabic, English, Persian and Spanish. Mr. Hassoun's dedication to diversity and inclusion stems from his life experience and he is focused on cultural competency, and seeking similarities and

common ground between different groups of people, as he works to increase diversity within the legal profession.
