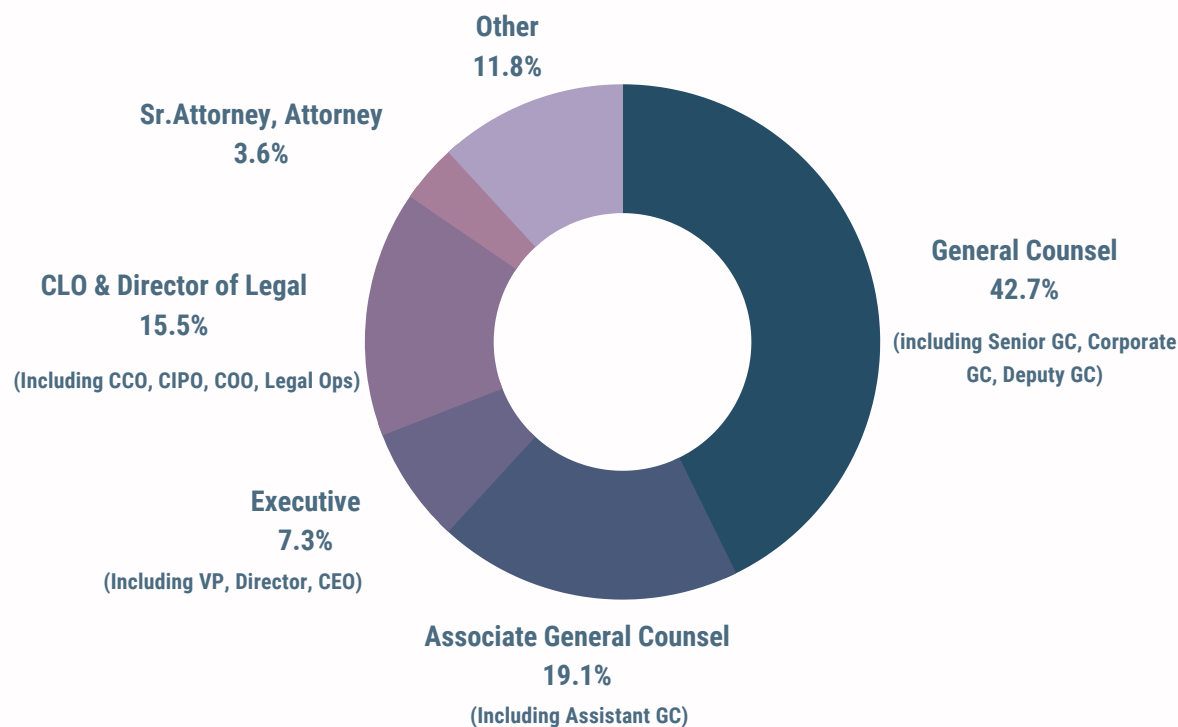

Applicants may submit up to three (3) substantive proposals and selection will be made by early April. Sponsors with a selected program must become a Gold Level Sponsor.

SILVER
