How do you define success?

When I worked for a big firm, even if I won a lawsuit that was 3 years in the making, that wasn't success to me nor motivating. But when I partnered with my dad it was awesome. Lots of court appearances, getting new clients, being able to pay my overhead after 2 months. I felt successful! Little bits of good and happiness sprinkled through life. Long dry spells or monotony isn't success even if I had a \$10M verdict 6 years after the complaint was filed.

Who inspires you?

To this day, my mom and dad still inspire me even though my dad passed away almost 20 years ago and my mom turns 88 shortly. I was fortunate enough to partner with my dad and join my parents in the practice of law after my 5 year big law stint in Minneapolis. We worked hard but my dad ensured that we all had fun while doing it...celebrating the successes and figuring out how we could do better next time, while my mom marketed the firm as a leader of the community and made sure our clients paid their bills. My memories of walking to the courthouse with my dad arm in arm and giving each other a kiss before we walked through separate courtroom doors, are precious, inspiring moments to ensure that I continue to love the law and celebrate life.

What's one thing - industry-related or not - you learned in the last month?

I have been learning how vastly different the civil litigation system is in France compared to the US. For instance, there is no routine discovery, you need to petition the court to get an expert and then, the expert represents the court and does not opine on behalf of either party, the judges are astute in the field / industry at issue and there is no or very little witness testimony or oral argument. Truly eye opening. I am grateful for the greater transparency that discovery brings here in the US, and as a former trial lawyer, the ability to address and examine witnesses, but it will be interesting to see how each case unfolds.

What's the last book you read?

I cheat now and listen to audio books via my local library app during my commute. It is amazing...and free! I choose mostly biographies or historical fiction, like my current listening pleasure; Scott Turow's Ordinary Heroes. It recounts a young attorney's life transformation when his cushy, but monotonous JAG Corps position ended up landing him on the front line as a commanding officer during WWII.
