Indian Country

- (a) all land within the limits of any Indian reservation under the jurisdiction of the United States Government, notwithstanding the issuance of any patent, and, including rightsof-way running through the reservation,
- (b) all dependent Indian communities within the borders of the United States whether within the original or subsequently acquired territory thereof, and whether within or without the limits of a state,
- and (c) all Indian allotments, the Indian titles to which have not been extinguished, including rights- of-way running throughout the same.
- 18 U.S.C. 1151
