Check the sources. A high school English teacher always made us look up words we misused or misspelled, rather than just correcting our papers. Early in my career, a litigation partner took the same approach with civil procedure rules. To this day, I don't assume I am doing something the right way just because it has always been done that way, but will check the sources to confirm what they actually say.
