A MESSAGE FROM THE GALA DINNER CHAIR



On behalf of ACC Southern California's Board of Directors, I am delighted to welcome you to our 25th Annual Gala Dinner and Pro Bono Silent Auction! The Gala Dinner is our chapter's marquee event and is intended to unite our members, sponsors, and guests as we explore the life, careers, and achievements of world leaders in law, politics, and entertainment. In



addition, the Gala is time for us to honor our peers who serve the Southern California community through their commitments to diversity, equity, and inclusion, as well as pro bono services to the underserved and underrepresented.

Tonight's distinguished speaker is Amal Clooney. Ms. Clooney is a barrister who specializes in international law and human rights. She represents clients before international courts, including the International Criminal Court, the International Court of Justice, and the European Court of Human Rights. Many of her clients are victims of human rights abuse, like women from the Yazidi community -- including the 2018 Nobel Peace Prize Laureate, Nadia Murad -- who are seeking accountability following a campaign of executions, assaults, and enslavement by ISIS in Iraq and Syria. She has represented Armenia in a case involving the Armenian genocide and was recently counsel to 126 victims of the genocide in Darfur, Sudan, at the International Criminal Court.

Ms. Clooney also represents political prisoners around the world and has received many honors for her work to secure the freedom of journalists arbitrarily detained across the globe. For the past two years, Ms. Clooney has represented Maria Ressa, a leading journalist in the Philippines who won the 2021 Nobel Peace Prize, despite being jailed for her campaign of free expression and democratic government.

In 2016, Ms. Clooney and her husband, George, established the Clooney Foundation for Justice, which operates in more than 40 countries. One of their initiatives, TrialWatch, shines a light on injustices by monitoring criminal trials and advocating for the rights of imprisoned journalists, LGBT persons, women, minorities, and human rights defenders. The Foundation currently investigates war crimes in Ukraine.

Tonight, we also celebrate two special honorees. The Southern California Edison Law Department is the 2022 Pro Bono Counsel of the Year, and Senior Vice President, General Counsel, and Corporate Secretary of Tetra Tech, Preston Hopson, is the 2022 Diversity Counsel of the Year. In recognition of these achievements, ACC Southern California is pleased to make contributions to each of their selected pro bono legal organizations.

This evening would not be possible without the dedicated work of the ACC Southern California Board of Directors, led by President Victoria Harvey; Past-President Joni Gaudes; the spirited Gala Dinner committee; and our incredibly thoughtful and diligent Executive Director, Betty St. Marie – thank you!

A Moderated Conversation with

AMAL CLOONEY

Lawyer & Human Rights Advocate

Amal Clooney is a barrister who specializes in international law and human rights. She represents clients before international courts, including the International Criminal Court, the International Court of Justice, and the European Court of Human Rights.

Ms. Clooney is ranked in the leading legal directories Chambers and Partners and Legal 500 as one of the top lawyers in the UK in the fields of international human

rights and international criminal law. According to the rankings, she is described as "a brilliant legal mind" who "handles cases of real international importance" and has a "passionate commitment to the law and compassion for the people it serves."

Ms. Clooney represents victims of human rights abuse and has argued many landmark cases throughout her career. She has for many years represented women from the Yazidi community -- including the 2018 Nobel Peace Prize Laureate, Nadia Murad -- who are seeking accountability following a campaign of executions and sexual enslavement by ISIS in Iraq and Syria. In 2020 she represented a Yazidi woman in the world's first trial in which an ISIS member was convicted of genocide. She also represents Yazidi victims in the first case alleging complicity in crimes against humanity by a company that funded the terror group. She has represented Armenia in a case involving the Armenian genocide and was recently counsel to 126 victims of the genocide in Darfur, Sudan, at the International Criminal Court. And in 2021 she was appointed Special Advisor to the Prosecutor of the International Criminal Court on Darfur.

Ms. Clooney also represents political prisoners around the world and has received many honors for her work to secure the freedom of journalists arbitrarily detained across the globe. For the past two years, she has represented Maria Ressa, a leading journalist in the Philippines, who faces over 100 years in prison based on spurious charges and

was the 2021 winner of the Nobel Peace Prize. She has acted as counsel Khadija Ismayilova, an investigative reporter imprisoned in Azerbaijan for reporting on corruption; Mohamed Fahmy, when he was Al Jazeera's bureau chief in Cairo; and two Pulitzer Prize-winning Reuters journalists who were imprisoned in Myanmar in 2019 following their reporting on crimes committed against the Rohingya. All these journalists were released from prison following Ms. Clooney's representation.

Ms. Clooney also served as a Senior Advisor to Kofi Annan when he was the UN's Envoy on Syria and as Counsel to the UN Inquiry on the use of armed drones. She has been appointed to the UK's panel of experts on combatting sexual violence and to an expert panel established by the UK Attorney-General on public international law. In 2019 she was appointed the UK's Special Envoy for Media Freedom by the UK Foreign Secretary and served until recently as vice-chair of the High-Level Panel of Legal Experts on Media Freedom chaired by the former President of the UK Supreme Court.

Ms. Clooney is a Visiting Professor at Columbia Law School, where she co-teaches the Human Rights course, and she is co-author of an academic textbook titled *The Right to a Fair Trial in International Law*, published by Oxford University Press. The book has been heralded as the "definitive work" in the field, a "great work that will sustain people around the world in their fight for justice" and cited by the UK Supreme Court.

In 2016 she and her husband George established the Clooney Foundation for Justice to advance justice through accountability for human rights abuses around the world. One of their initiatives, TrialWatch, shines a light on injustices by monitoring criminal trials and advocating for the rights of imprisoned journalists, LGBT persons, women, minorities, and human rights defenders. Another flagship initiative, The Docket, gathers evidence of genocide, war crimes, and crimes against humanity to trigger prosecutions and civil suits and advocates for the rights of victims in those trials. The foundation's most recent initiative – Waging Justice for Women – uses strategic litigation to advance women's rights in Africa.

Preston Hopson is Senior Vice President, General Counsel, Chief Compliance Officer and Corporate Secretary at Tetra Tech, Inc. Mr. Hopson was previously a senior associate in the capital markets group at O'Melveny & Myers, LLP. He began his legal career as a Judicial Clerk to the Hon. Raymond C. Fisher on the U.S. Court of Appeals for the Ninth Circuit.

Mr. Hopson is a proud member of the Association of Corporate Counsel, having served two terms on the Southern California Chapter Board of Directors. He is a member of the Leadership Council of the Posse Foundation, which provides college scholarships to high school students with extraordinary leadership potential. He has been recognized for his contributions to the Black General Counsel 2025 Project, an initiative that prepares Black lawyers who are equipped to become general counsel of public companies. Mr. Hopson regularly speaks at conferences and programs promoting the importance of diversity in the legal community. He also is an adjunct professor of securities law at the USC Gould School of Law.

Mr. Hopson received both a B.A. in Ethics, Politics and Economics and J.D. from Yale University.



History

ACC America and Its Southern California Chapter

On December 1, 1981, Robert Banks, then vice president and general counsel of Xerox Corporation, hosted a luncheon that triggered a chain of events that would change the legal profession. The participants -- mostly general counsel of their companies -- included Lawrence Kraus (U.S. Chamber of Commerce), Philip Knox, Jr. (Sears, Roebuck and Co.), Carl Liggio (Arthur Young and Company), Stephen Middlebrook (Aetna Life and Casualty), Donald Walsh (Sun Company, Inc.), William Weitzel, Jr. (Texaco, Inc.), Irving Yoskowitz (United Technologies Corporation), and Guy Zoghby (IBM Corporation).

An Overwhelming Response from the Very Beginning

As a result of that initial luncheon meeting, 55 leading general counsel were invited to attend a March 14, 1982, meeting at the AMFAC (now Hyatt) Hotel at the Dallas Fort-Worth Airport to discuss the formation of an organized group for in-house counsel. Although no one knew how the invitation would be received, 53 out of the 55 invited general counsel showed up. This overwhelming response demonstrated that a common chord had been struck.

The lunchtime thoughts of nine visionary in-house counsel took root and have grown into America's -- and the world's -- leading in-house counsel bar association. On a global basis, ACC currently has more than 40,000 members in the U.S. and abroad. In 2003, ACCA changed its name to Association of Corporate Counsel or ACC, in acknowledgement of its global status.

In Southern California, Peter Zeughauser (The Irvine Company), Oscar Glass and several other talented in-house counsel took the initiative in late 1984 and founded the Southern California Chapter of the Association of Corporate Counsel to serve the professional interests of ACC members in Los Angeles, Orange, Ventura, and Santa Barbara counties, as well as portions of Riverside and San Bernardino counties. Mr. Zeughauser later served as the 1991 Chair of ACC Southern California's Board of Directors.

Since the founding of ACC Southern California hundreds of energetic, civic-minded, and service-oriented in-house attorneys of diverse backgrounds have volunteered their time and talents to serve as officers, members of the Board of Directors, and committee members for ACC Southern California. In addition, many other ACC Southern California members have served in leadership positions at the national ACC level, such as on the Board of Directors and as National Committee members. To date, ACC Southern California has over 1,600 members in Southern California, all of whom are in-house counsel.
