Prior to Home Chef, Shane was a Tax Associate in the Corporate group at Kirkland & Ellis LLP in Chicago.



Currently, Shane lives in Chattanooga, TN, with his wife (Elaina) and their dog (Liga) and cat (Plato), where he spends his free time trail running, mountain biking, fishing and swimming in the Tennessee River, and generally spending as much time outdoors as possible. 
