Definitions

The terms implied by sections 3 to 5 of the Supply of Goods and Services Act 1982 are, to the fullest extent permitted by law, excluded from this agreement.

- The clause includes exceptions for death or personal injury caused by negligence, fraud or fraudulent misrepresentation, and liability that cannot be limited or excluded by applicable law.

### Missing Information:

- The clause does not carve out liability for breaches of confidentiality or data protection obligations.
- The clause does not include a provision for liability in relation to third party claims of intellectual property infringement.

### Additional Information:

- The clause includes the exclusion of liability for loss of profits, sales or business, agreements or contracts, anticipated savings, goodwill, use or corruption of software, data or information, and any indirect or consequential loss.
- The clause includes a limitation of liability to the higher of £5,000,000 or the total charges paid under the agreement in the preceding twelve months.

### Suggested Wording:

Subject to clause 9.1, neither party shall be liable to the other, whether in contract, tort (including negligence), for breach of statutory duty, or otherwise, arising under or in connection with this agreement for loss of profits; loss of sales or business; loss of agreements or contracts; loss of anticipated savings, loss of or damage to goodwill, loss of use or corruption of software, data or information, any indirect or consequential loss, except for claims arising out of: (i) a party's breach of confidentiality obligations; (ii) a party's breach of data protection obligations: (iii) any claims from a third party that the party's services infringe or misappropriate any Intellectual Property Right of such third party; and (iv) a party's breach of indemnity obligations.
