THE PROMISE VS. THE REALITY

• The 2022 Justice Gap Report of the federal Legal Services
Corporation found that **92 percent** of the civil legal problems
reported by low-income Americans received inadequate or no legal
help.

• Similar Virginia studies in 1991 and 2007 found that **80 percent** of the legal problems of low-income Virginians received no help from an attorney.

RATES OF REPRESENTATION & OUTCOMES

The equal justice ideal cannot be realized without access to legal services - to lawyers, in particular.

- Most Virginia civil cases include at least one unrepresented party.
 - Both parties represented in only 1% of GDC cases, 6% of J&DR cases, 38% of Circuit Court cases
- There is an association between poverty and lack of representation.
- Litigants represented by counsel are in general <u>twice as likely</u> to receive a positive outcome as those who are unrepresented.


VIRGINIA POPULATION & ACCESS TO LAWYERS

POVERTY POPULATION PER LEGAL AID LAWYER



There is one legal aid attorney for every 3,073 Virginians below the poverty line.

GENERAL POPULATION PER ACTIVE LAWYER




There is one active Virginia attorney for every 240 Virginians of any income.

AVERAGE CASELOAD NEEDED TO BEGIN MEETING DEMAND




Approximately 2000 cases would be needed per legal aid attorney.

CURRENT AVERAGE CASELOAD



Approximately 100 cases are currently being worked on per legal aid attorney.

100 cases annually is currently straining the 280 legal aid attorneys in Virginia!



PRO BONO IN RESPONSE TO OUR CIVIL JUSTICE CRISIS

If "Justice for All" is going to be more than an empty phrase at the end of the Pledge of Allegiance, Virginia needs the sustained engagement of every attorney in *pro bono* assistance.



THE BAR'S MISSION

- I) to protect the public;
- 2) regulate the legal profession of Virginia;
- 3) advance access to legal services; and
- 4) assist in improving the legal profession and the judicial system.

Virginia Rules of Professional Conduct Preamble

A lawyer should be mindful of the deficiencies in the administration of justice and of the fact that the poor, and sometimes persons who are not poor, cannot afford adequate legal assistance, and should therefore devote professional time and civic influence in their behalf. A lawyer should aid the legal profession in pursuing these objectives and should help the bar regulate itself in the public interest. . .



Rule 6. I of the Virginia Rules of Professional Conduct establishes goals for pro bono service with equal justice ideals in mind and with the hope of increasing access to legal services for those unable to afford an attorney. 2%

A lawyer should render at least two percent per year of the lawyer's professional time to pro bono public legal services.



Pro bono publico services include poverty law, civil rights law, public interest law, and volunteer activities designed to increase the availability of pro bono legal services.



A law firm or other group of lawyers may satisfy their responsibility collectively under this Rule.



Direct financial support of is an alternative method for fulfilling a lawyer's responsibility under this Rule.

RULE 6.1

CATEGORIES OF PRO BONO SERVICE

Direct Pro Bono Legal Services

- Poverty Law
- Civil Rights Law*
- Public Interest Law*

*no requirement that the client is unable to afford an attorney

Other Volunteer Services to increase pro bono

CATEGORIES OF PRO BONO SERVICE

Direct Pro Bono Legal Services

- The free or nominal fee nature of the work must be established in advance for the work to qualify as pro bono (unpaid fees don't count)
- Inexperience does not preclude service Rule 1.1
 - lawyers can gain competency through training,
 prep, and research.



Providing low bono or pro bono legal assistance to someone who lacks the financial resources to hire a lawyer.

(Comment 2)

- Lack of ability to pay is key
- Fulfills the equal justice promise for economically disadvantaged
- Structured programs provide benefits, but ad hoc service does count.



Engaging in volunteer activities designed to increase the availability of pro bono

(Comment 5)

- Does not require provision of legal services
- Training and mentoring pro bono lawyers
- Recruiting pro bono lawyers
- Drafting materials that pro bono attorneys will use
- Performing intake or screening services for legal aid or other legal services programs that serve clients consistent with Rule 6.1 (a) priorities.
- Serving on boards, committees or bodies that increase access to pro bono services on the state or local level (e.g. your firm's pro bono/public service committee)

RULE 6.1 IS NOT MANDATORY BUT...

COMMENT[I] Every lawyer, regardless of professional prominence or professional work load, has a personal responsibility to provide legal services to those unable to pay, and a personal involvement in the problems of the disadvantaged can be one of the most rewarding experiences in the life of a lawyer.

WHY DO IT IF IT'S NOT MANDATORY?

Bench and bar leaders care about pro bono.

Get experience, including time in court.

Pro Bono work can be great PR for firms and corp. clients are looking at it.

Flex legal research and lawyering skills muscles. Learn a new area of the law.

Reinvigorate your passion for the law.

The VOLUNTARY Pro Bono Reporting Rule

The addition of Paragraph 22 of Part Six, Section IV, of the Rules of the Supreme Court adds a new voluntary pro bono reporting rule to complement Rule 6.1 aspirational pro bono service goals.

PRO BONO NUMBERS IN VIRGINIA

355,199.7 hours of pro bono service

More than \$1.7M in financial contributions

12% reported hours greater than zero.

Those who reported service time contributed an average of 63.5 hours.



• If we had 100% participation with this aspirational goal, we would be providing more than 1.8 million hours of pro bono.



RULE 6.1 ASPIRATIONS WHY ARE WE FALLING SHORT?

- Time constraints
- Commitment to family obligations
- Lack of skills or practice experience in the practice area needed
- Competing billable hour expectations and other firm policies
- The cost and financial burden on their practice
- The lack of administrative support
- The lack of malpractice insurance
- Fear of getting in over one's head too much work for too long

WHAT IS VIRGINIA FREE LEGAL ANSWERS?

Online pro bono Q&A portal

Anonymous, flexible, customizable, and limited in scope

ABA initiative - interactive website to provide online pro bono assistance to low-income citizens (poverty law category of Rule 6.1).

45 states have signed up for the project to date with more in the process.

Virginia site launched August 22, 2016, and has served more than 10,000 qualified individuals.

THE Q&A PROCESS

Eligible client user (next slide) posts a request for legal advice.

Licensed VA lawyer reviews questions and selects those they want to answer.

If an attorney responds to a question, the client user receives an email but must log in to view the written response.

The attorney and client engage in a dialogue.

The attorney closes the dialogue after answering the question.

CLIENT ELIGIBILITY AND REGISTRATION

Rule 6.1 "Poverty Law" – serving "people who do not have the financial resources to compensate a lawyer." Comment [2]

250% of the federal poverty guidelines or less; no more than \$10K liquid assets

Prospective client user logs in and answers registration questions to qualify

Users are limited to three questions per year

Civil legal issues only – no criminal or traffic matters

If ineligible, referred to other resources

REMOVING PRO BONO BARRIERS

Time constraints?

- Manage your time as you prefer; it's as easy as answering an email.
- Do it anytime, from anywhere with an internet connection.
- Average question takes 20 minutes or less to answer.

Lack of skills or practice experience in poverty law?

- You pick the questions you feel comfortable answering or have time to research.
- Training resources available through the state administrator.
- Remember, Rule 1.1 inexperience does not preclude service!

REMOVING PRO BONO BARRIERS

Competing billable hour expectations and policies?

- Sign on when your workload is more manageable.
- You can ignore the queue entirely during busy times in your practice.

Cost and financial burden a concern?

- Provided to the VSB for free! Dues don't pay for the service. Users don't pay a fee.
- Limited-scope engagement means no expenses that would be associated with trying a case (experts, court reporters, travel, printing, etc.)

REMOVING PRO BONO BARRIERS

Lack of administrative support?

 Administered by the ABA and supported by VSB director of Access to Legal Services.

No malpractice insurance?

• Volunteer attorneys answering questions on the website are covered under ABA/NLADA malpractice policy.
