Number of Years In-House

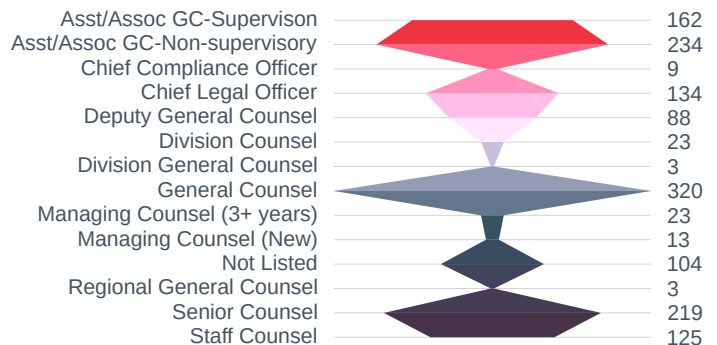

### HISTORY

- The Washington Metropolitan Area Corporate Counsel Association ("WMACCA") was founded in 1980 to "provide a forum for discussion of the concerns of corporate legal counsel in the Washington, D.C., metropolitan area." We were one of the first organizations of corporate staff attorneys in the United States.
- ACC was founded in 1982 by a group of general counsel who believed that in-house counsel needed their own organization focused exclusively on in-house issues and networks.
- WMACCA affiliated with ACC in late 1983 as the Washington Metro Area chapter.
- In 2006, WMACCA broadened its service area from Washington, D.C. and the surrounding Virginia and Maryland suburbs, to include all ACC members throughout the Commonwealth of Virginia.
- In January 2015, WMACCA became the ACC National Capital Region chapter, in order to better describe the area it serves and more closely identify with ACC and other chapters.
