ACC NCR, along with ACC Global and the ACC Foundation, hosts an annual Street Law Diversity Pipeline Program with Potomac High School in Oxon Hill, Maryland, which brings together members to teach high school students about the law and expose them to in-house practice. During 2023, Rebecca Knight stood out among her volunteer peers for her "leadership, commitment, advocacy, and vulnerability" according to Prince George's County educator Nissa Copemann, who

nominated Rebecca for the Outstanding ACC NCR Volunteer Award.

During the 2023 Street Law Capstone, Rebecca shared her personal story of overcoming seemingly insurmountable challenges to attend law school and become an attorney. Taking her commitment to helping the next generation of lawyers succeed to another level, Rebecca worked with her then-employer, BBB National Programs, to arrange a school-supply drive for participating students, ensuring that each one received a backpack full of critical school supplies and gifts. The most significant gift: a new laptop with two years of support service! "Rebecca's commitment and dedication to ensuring that she made a notable difference in the lives of the students was inspiring," wrote Nissa.

Rebecca's story, candid commentary, and her ability to relate to the students contributed to several of them potentially pursuing a law career. "Her words helped them envision their futures as successful and contributing members of the legal community," penned Nissa. Street Law students in attendance went on to enroll in institutions like the University of Maryland; Prince George's Community College; Rutgers; and William & Mary.




#### **MEGAN WESSEL**



# Challenge Champion


Riaz Dhanani, senior corporate counsel at CarMax, Inc., joined the legal team at the used vehicle retailer four years ago and quickly became an integral member of the department. In his current role, he runs CarMax's bifurcated securitization platform and manages five funding warehouse facilities, the revolving credit facility, and

multiple term loans and private placement notes - all totaling over \$10 billion in transactions.

In addition to his complicated day-to-day responsibilities, he has thrived in numerous roles outside of his expertise and comfort zone. For example, he leads CarMax's legal effort to achieve a 50% carbon emissions reduction by 2025. In 2023, he sold CarMax's corporate jet and purchased a new one for the company and very recently completed the process of adding a new nonprime securitization platform to bring the company over \$1B more in transactional work. He is regularly asked to take on stretch assignments and happily accepts new challenges to help improve the organization.

Riaz demonstrates commitment to his colleagues and peers by serving on the legal team's social committee; working to make the team more collaborative (within and outside the department); and further, through leading important discussions around DEI, a topic of importance to the attorney dedicated to ensuring all feel welcome in the CarMax legal department. According to his team, Riaz's ability to tackle new challenges, as well as his passion for his colleagues, has made the legal department a stronger, more cohesive unit.

# **Leadership Through Disruption**BEACON ROOFING SUPPLY, INC.



During a year of significant change for Beacon, a Fortune 500 publicly traded company, the Office of the General Counsel (OGC), led by Executive Vice President and General Counsel Christine Reddy, played an integral role in the company's milestone

achievements. Committed to Beacon's strategic vision, the OGC partnered with the business to drive growth, expand the footprint, successfully deploy capital, and realign the capital structure by reducing a significant private equity owner's position. Demonstrating a commitment to the client, mitigating risks, and building a high-performing team, the OGC team also resolved litigation, developed more effective and efficient processes and tools, and explored innovative technologies to deliver standardized and tailored results.

The OGC negotiated and completed public offering transactions which reduced private equity firm CD&R's beneficial ownership of the company from 34 to 8 percent. These 2023 transactions included the repurchase of CD&R's outstanding Series A Preferred Stock funded by \$600M of Senior Secured Notes; and the completion of two \$420 M public offerings for the sale of shares of Beacon's common stock. In addition, Beacon's legal team contributed to the company's overall growth by negotiating and closing on leases that added 35 greenfield locations and successfully acquiring more than eight privately held company assets. The team also worked closely with HR to implement the first ever employee stock purchase plan.

In her nomination, Abby Brown, partner at Squire Patton Boggs (US) noted the OGC's wise investment of time and resources as they displayed great leadership through disruption.

The team also counts developing and launching employee training programs to help global team members understand applicable legal, regulatory, and ethical obligations as key 2023 successes.

**DEI Leader**CONSTANTINE ATHANAS

Among the many accomplishments of James G Davis Construction Corporation (DAVIS) Executive Vice President and General Counsel Constantine Athanas in 2023, his commitment to diversity, equity, and inclusion (DEI) stands out.

A founding member of the DAVIS DEI Steering Committee in 2021, he chaired the committee from its inception through 2023. Under his leadership, DAVIS updated its 40-year-old core values to include "inclusion" which became the guiding principle for several initiatives throughout the company, including: a pay equity study; creation of three employee resource groups; participation in Construction Inclusion Week; sponsorship of the Leadership of Greater Washington Anti-Racist Leadership Series; expansion of the company's recruiting sources; company-wide anti-bias education; celebration of cultural observances (including Pride Month and Juneteenth); extension of the company's parental leave benefits; and expansion of PTO to include two floating holidays for religious and cultural observances not already in the DAVIS calendar.

Constantine's commitment to DEI extends beyond his legal department and DAVIS. He has served as co-chair of the ACC NCR DEI Committee since 2020, overseeing the increase in that committee from four to forty members and expansion of the committee's activities to programming, leadership development, and affinity groups. Moreover, he has demonstrated a tremendous commitment to ongoing education on DEI topics and personal action to make the communities in which he operates more diverse, equitable, and inclusive.



# Transactional Achievement

The 2024 Outstanding CLO Award – Transactional Achievement goes to Executive Vice President and General Counsel Taryn Fielder for her leading role in Veris Residential's transformation to a pure-pay multifamily REIT (real estate investment trust) last year.

Due to Taryn's strategic advisory support, the company was able to advance several key milestones. For example, Taryn was instrumental in the successful sales of non-core office assets, including one of the largest commercial office transactions of 2023 totaling \$420M, and the \$97M sale of Port Imperial Hotel. She also led negotiations related to Rockpoint's interest in the company's multifamily portfolio in a transaction valued at \$520M, which substantially simplified the overall company structure and is projected to save approximately \$24 million of annual interest. Further, Taryn was a lead player in successfully defending Veris against a publicly threatened activist investor campaign.

In addition, Taryn's work has greatly contributed to driving higher revenues, reducing concessions across Veris Residential's portfolio, and stabilizing controllable expenses. More specifically, she is credited with reducing annual legal fees by 47 percent in 2023 — achieved due to her ability to bring legal work in-house while also developing and elevating her team.

A 2022 graduate of the ACC NCR Leadership Academy, Taryn accomplished tremendous success for Veris Residential while serving as a member of the ACC NCR Leadership Academy Steering Committee and a co-chair of the CLO and General Counsel Club, as well as on the Board of Trustees at Eckerd College.

Paul Mamalian, executive vice president and general counsel of Avolta
North America, is this year's recipient of the 2024 Outstanding CLO Award –
Integration Maven, in recognition of his many legal accomplishments, leadership across the business, and commitment to excellence and innovation within the in-house community.

Most notably in 2023, Paul led integration of two sizable and sophisticated legal departments following the complex merging of HMSHost's food and beverage business, Hudson retail operations, and Dufry's duty free offerings into Avolta North America. In his nomination, Jay Halpern, partner at ArentFox Schiff noted that Paul's "strategic vision and adept management ensured that the new legal department was optimally structured to support Avolta's multifaceted business operations." First and foremost was the redevelopment of the company's Tribal Member Management Development program for tribal citizens at THTBC. Virginia, who holds the prestigious Certified Compliance and Ethics Professional (CCEP-I) designation, demonstrated her deep understanding of legal regulations and compliance processes when collaborating with THTBC's CEO and vice president of human resources on the program. The revitalized plan seeks to grow tribal leaders at all levels of the company, thereby providing important succession planning and bolstering the Tribe's goal of economic sovereignty.

In addition, Virginia was responsible for overseeing the build-out of THTBC's new 10,000-square-foot flagship office, including the installation of "Skybound Determination" created for THTBC by tribal citizen Rico Worl. Virginia also led the company's rebranding efforts, including the development of a new logo and website.

As Partner and Government Contracts Chair at Fluet David Panzer noted in his nomination, Virginia's "leadership style fosters collaboration and leverages her creative-problem abilities" – essential ingredients for innovation. ACC NCR benefits from her leadership as well. A 2018 ACC NCR Leadership Academy alum, Virginia serves as co-chair of both the Leadership Academy Steering Committee and the Litigation Committee. Over the course of more than six years supporting the Association of Corporate Counsel National Capital Region Chapter (ACC NCR), Kasha Hunt worked with many vice presidents of programming, committee chairs, speakers, and sponsors in the production of almost 500 legal education programs. Under her leadership, the chapter hosted four successful annual DEI Conferences, culminating with the 2024 Conference that combined Kasha's CLE expertise with her commitment to DEI.

#### **MURRAY GARNICK**

On April 1, 2024, Murray Garnick retired as executive vice president and general counsel at Altria Group, Inc. Murray joined Altria Client Services, LLC in 2008 as head of litigation, specifically senior vice president and associate general counsel, following more than 20 years representing the company and its subsidiaries in private practice.

#### A Few Highlights from an Exemplary Career:

Implementation of the Trial School. When Murray went in-house at Altria, the company was preparing to try potentially thousands of cases in Florida. Immediately, he noticed that his trial lawyer roster lacked diversity and were overwhelmingly white men. Understanding that juries reflect the community, and the trial roster did not, Murray implemented an innovative trial school aimed at recruiting and developing trial lawyers who reflected the diversity of the juries before who the lawyers try their cases. It was expensive and it took several years, but, today, Altria's trial roster consists of many talented lawyers who look a lot more like the juries they face in court. This massive investment provided incredible opportunities for the lawyers involved and has resulted in an impressive trial record for the company.

**Requirements for Outside Firm Partnerships.** Murray enforced a policy requiring that the company's primary outside law firms have at least one "diverse" relationship partner, meaning an attorney from an underrepresented community. This simple policy shifted law firm power dynamics and resulted in outside counsel from various backgrounds serving in roles where they could thrive and drive important firm business — thereby progressing through law firm hierarchies.

Legal Work that Speaks for Itself. The career attorney kept an eye out for superb lawyers, both in-house and outside counsel. When it came to his work with outside attorneys, Murray focused on quality and dedication and loyalty to the client. He hired diverse lawyers for major appellate assignments, bet-the-company trial roles, and critical regulatory matters. As far as those within his legal department, Murray identified talent within its ranks, provided stretch opportunities to those deserving, and made sure all were adequately recognized.

"Some general counsel speak at conferences, write articles, and put together committees to tackle the difficult issues facing the legal profession on diversity and inclusion matters. Those things are valuable," wrote Daphne O'Conner, a partner at Arnold & Porter who nominated Murray for this award. "However, it's also valuable to simply hire and develop diverse lawyers to do important work and provide them the space to shine. Murray is a doer. And the legal profession is better as a result."





#### JERALD "JERRY" S. HOWE, JR.

Jerald "Jerry" S. Howe, Jr., currently counsellor to the Chief Executive Officer of Leidos, served as the company's executive vice president, general counsel, and board secretary through March of 2024. In that capacity, he had responsibility for legal, contracts, and corporate governance, as well as administrative oversight of the ethics and compliance and internal audit functions.

Before joining Leidos in 2017, Jerry alternated between private practice and in-house positions, developing expertise in litigation, government contracts, M&A, and aerospace and defense practices. Recognized as a leader in the government law and contracting community, Jerry brought his extensive background to make significant contributions to the engineering company. A highly visible leader in the industry and the legal community at large, Jerry is credited with raising the Leidos brand among his peers and industry competitors.

During his tenue at the company, Jerry also worked to mature Leidos' approach to ESG and public disclosures, and led both offensive and defensive protest activity in a highly contested federal acquisition environment, promoting company growth. These are just a few recent successes attributed to the former general counsel, who worked continuously to strengthen Leidos' legal function, promoting development plans, and hiring two well-qualified chief audit executives, for example.

Jerry's leadership and contributions to Leidos and the community extend well beyond his legal expertise. He has been a staunch supporter of pro bono, community service, professional development, and DEI. For example, Jerry was instrumental in attracting and hiring a representative legal team and served as the sponsor of Leidos' LGBTQ+ employee resource group — championing them among senior leadership and contributing to the enterprise's overall DEI efforts.

He has contributed greatly to ACC NCR as well. The popular speaker has shared his expertise and life lessons with members repeatedly. In 2020, he joined the Board of Advisors for the ACC NCR Leadership Academy and through his interactions with the Academy Fellows, has enjoyed sharing insights into the ways in which the leadership competencies addressed during a particular session relate to his own experiences as a lawyer and executive. Over the years, he has participated in the module on decision-making, where he shares with students his "values-based" approach to dealing with difficult problems and big decisions.

In addition to his service on the board of advisors for the ACC NCR Leadership Academy, Jerry currently serves as a moderator for the Aspen Institute; co-founder and treasurer of No Labels; a board member of both the USO National Capital District and National Security Space Association, as well as chair of the INSA Legal Affairs Roundtable.

His considerable experience, contributions to his department, organization, and community, and willingness to mentor the next generation of in-house counsel are among the many reasons why ACC NCR is excited to present Jerry with a 2024 Outstanding Career Achievement Award.

#### ANDREA L. BRIDGEMAN


Few in-house counsel in the National Capital Region have been as actively committed to access to justice and pro bono work or have had the tremendous impact as Andrea L. Bridgeman, retired associate general counsel at Freddie Mac.

Over a career that spanned 32 years with the mortgage company, Andrea touched and improved upon the lives of many, including the clients she served at work and

those she assisted through her pro bono legal services. Not satisfied with throwing one more starfish back into the water, the access to justice advocate has served on numerous committees and boards, including as a member of Freddie Mac's Pro Bono Initiative for 28 years (sometimes serving as chair); board member of the National Legal Aid & Defenders Association from 2016-2018 (where she also served on various committees); board member and two-time president of the Potomac Legal Aid Society from 2002-2009; and member the Access to Justice Commission of the Supreme Court of Virginia, starting in 2013 and continuing even now. In addition, Andrea was elected to the Bar Council 19th Circuit (Fairfax) of the Virginia State Bar three times and served on the Access to Legal Services Committee from 2006-2014, as a member of the Mandatory Professionalism Course Faculty from 2002-2005, and on the Corporate Counsel Section Board of Governors from 1991-1998. If that was not enough, she has been a frequent speaker, moderator, and mentor to in-house pro bono volunteers and others within her home state of Virginia and beyond.

Andrea retired from Freddie Mac and soon began lending her considerable talents to the ACC NCR Pro Bono Committee. In fact, having sworn to never practice law for pay again, she continues her pro bono work for several organizations including the Great Richmond Bar Foundation and the Lawyers Committee for Civil Rights Under Law. Not letting retirement stop her from making a difference, her pro bono work includes matters such as individual arrest and misdemeanor record expungement, small business and nonprofit clinics, and a wide variety of cases for VA FreeLegalAnswers. Plus, she serves as a Virginia election official.

She truly lives up to her motto, "Pick up' pro bono!" and has been recognized for her unwavering service by the Virginia Law Foundation, Virginia State Bar, ACC Global, the Fairfax Bar Association, Freddie Mac, and now, ACC NCR! Andrea L. Bridgeman is a most deserving recipient of the 2024 Access to Justice Award.







#### **LUISE WELBY**

Like her friend and fellow Access to Justice Award recipient, Luise Welby recently retired from Freddie Mac as senior associate general counsel — but not from her unwavering commitment to pro bono and access to justice.

Over several decades, Luise has spent countless hours providing pro bono legal services and serving in leadership positions at Freddie Mac as co-chair of its award-winning pro bono program, and with legal services organizations, including Legal Services of Northern Virginia (LSNV) and Tahirih Justice Center. She has been a leader at nonprofits such as Doorways for Women and Families and the American Heart Association/Lawyers Have Heart. Last, but not least, she has brought her experience and expertise to the Association of Corporate Counsel, both at the global level and for ACC NCR.

At Freddie Mac, she revitalized its pro bono program by establishing a menu of opportunities ranging from clinics to extended representation, as one size does not fit all. Importantly, she focused on creating opportunities for all members of the legal division, not just attorneys. As a result, Freddie Mac has been recognized both nationally and locally for the strength and breadth of its program, including full scale litigation without partnering with outside counsel.

Her leadership at LSNV helped transform the organization and the culture of pro bono in Northern Virginia. As a board member and ultimately president, Luise strengthened relationships with in-house counsel and large law firms through pro bono. Through her recruitment and inspiration, many inhouse pro bono leaders and large law firm partners joined the LSNV board, enhancing funding and the critical provision of pro bono legal services to those in need.

While already an LSNV volunteer, Luise first became involved with ACC as chair of the Global Corporate and Securities Committee in 2005, and then co-chair of ACC NCR's same chapter forum in 2009. Her commitment to pro bono only deepened as she became involved with ACC NCR's pro bono activities in 2011. To encourage more in-house counsel to participate in pro bono, she developed a strategy where Freddie Mac and other large law departments partnered with LSNV and Whitman-Walker Health to create pro bono clinics open to all chapter members. In 2012, she joined the chapter board as vice president of External Relations, further growing the chapter's pro bono program, which culminated in becoming chapter President in 2016. Her legacy continues today in the chapter's robust pro bono programming.

When it comes to encouraging others to participate in pro bono, Luise believes that the key lies in providing attorneys with the right tools to reduce the "fear factor." The chapter believes she has been instrumental in providing many attorneys with these tools — inspiring them along the way. Many will continue to benefit from her work to increase access to justice, and those she has trained and worked alongside will continue with her in this important work.
