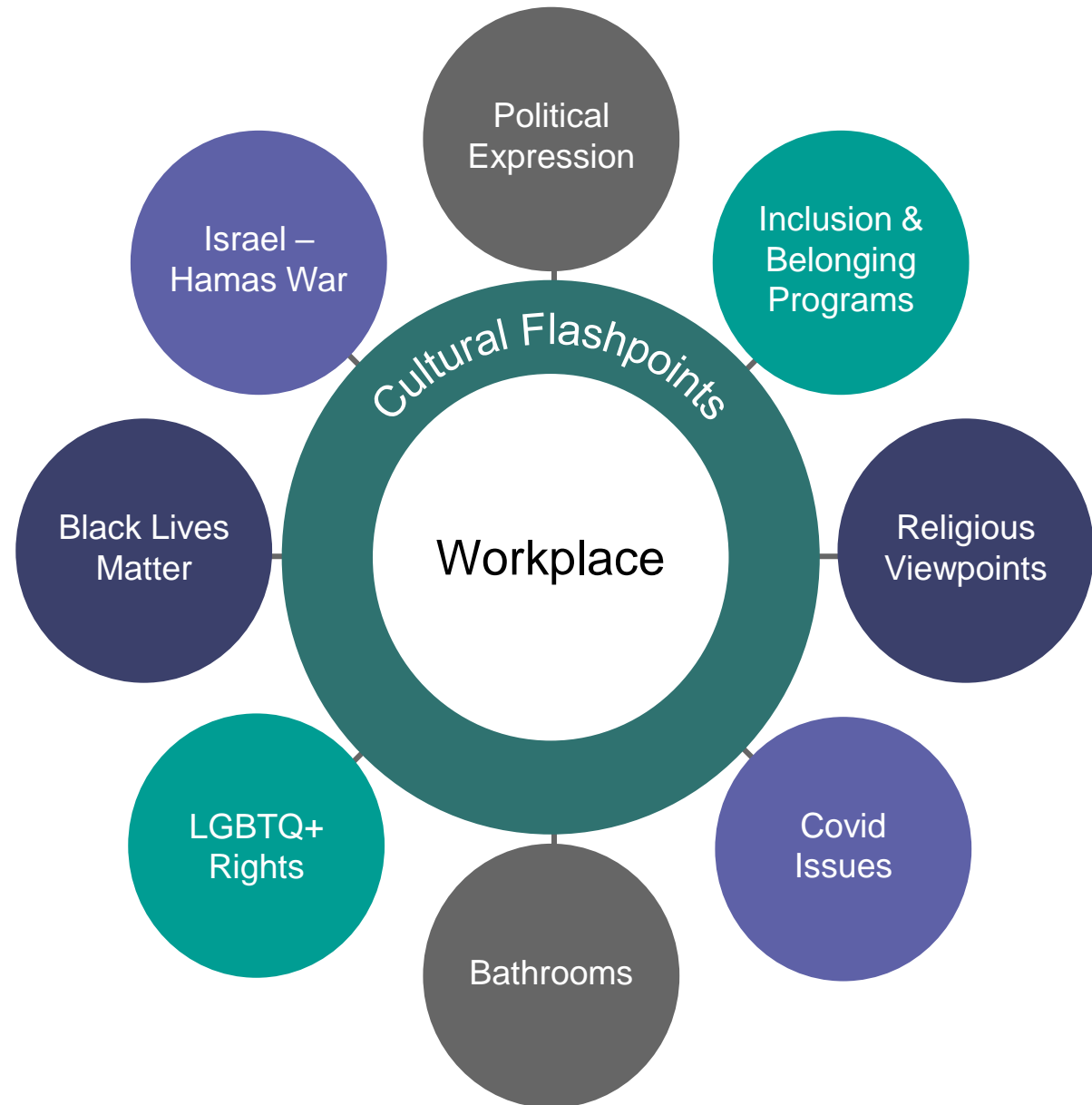

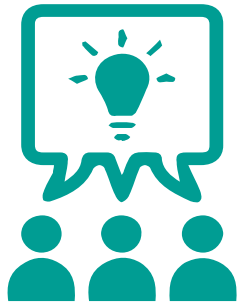

2025 Flashpoints

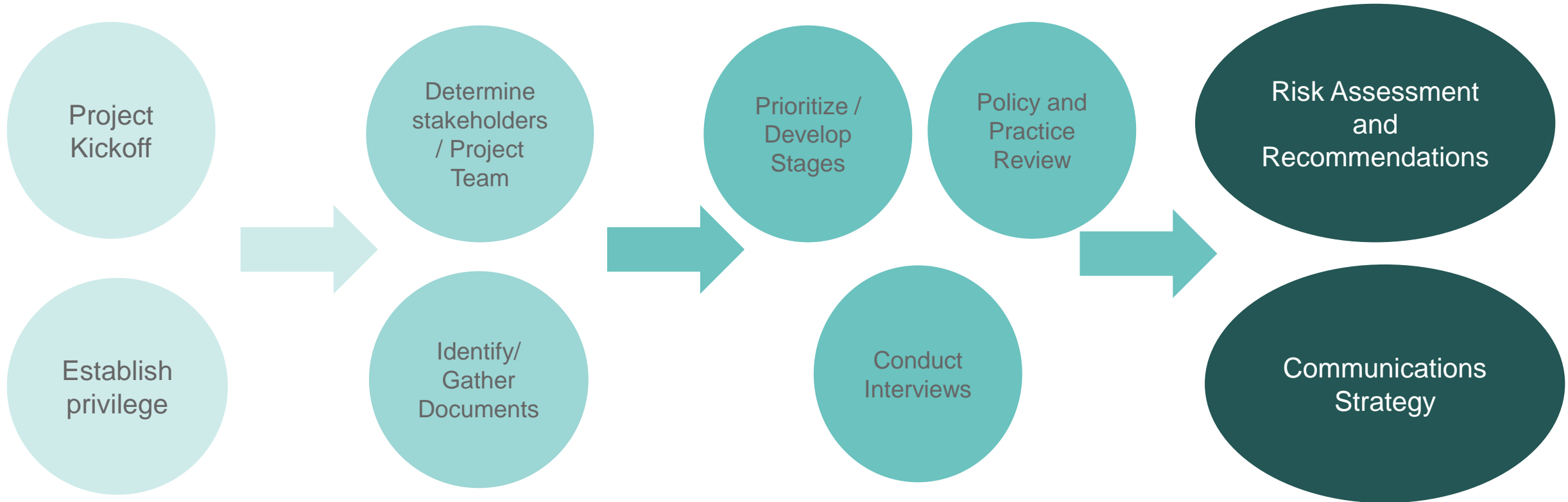
The change in Presidential administration is likely to cause a new wave of Flashpoints around issues including:

- New administration & political opposition
- International conflicts
- Immigration, travel bans
- Gender-affirming care and transgender rights
- Debates around “DEI”
- Anti-corporate sentiment
- Return to in-person work

Religious Issues

- Religious discrimination and accommodation claims
- Trends in Requests:
 - prayer space or a prayer room;
 - exemption from e.g., diversity training, Pride Month, using preferred pronouns;
 - faith-based ERGs;
 - exemption from vaccination programs;
 - training about specific religions.
- Litigation
 - claims of antisemitism and Islamophobia
 - claims of anti-Christian bias
 - ongoing litigation over mandatory vaccination policies

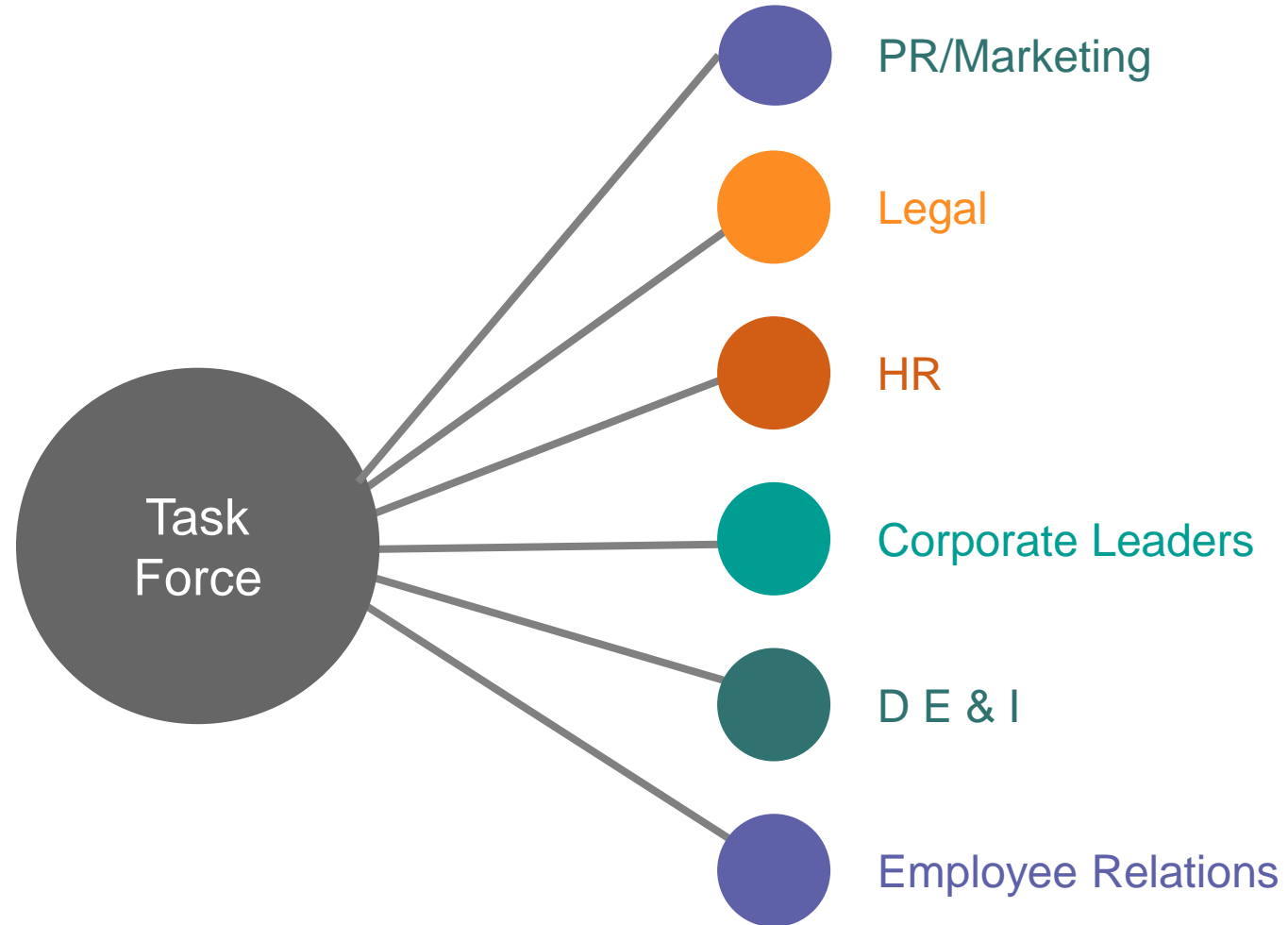

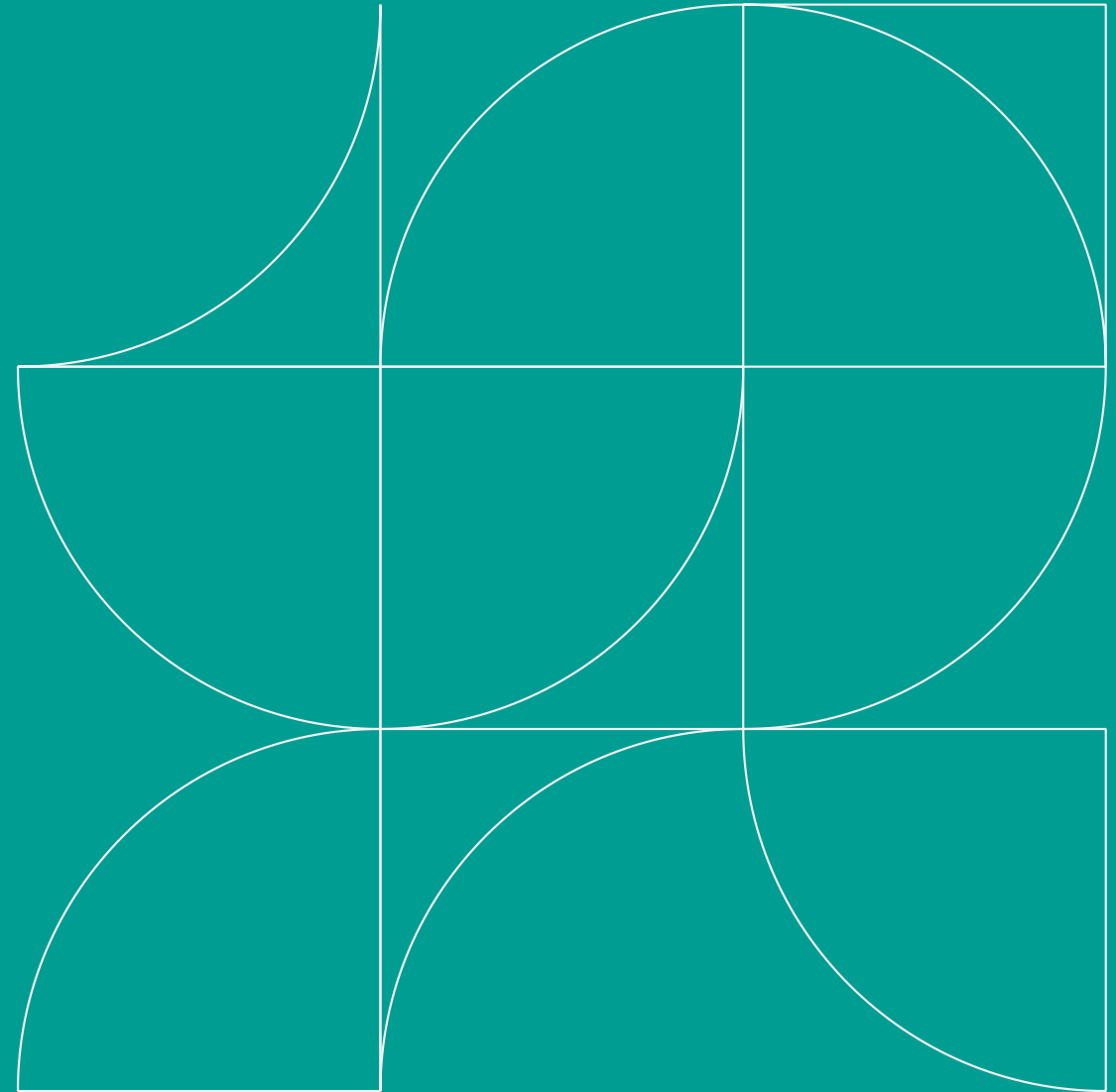
