





20% want something more automated than just calendars and calendar reminders.




35% want better communication & notifications to and from stakeholders and counterparties.



28% want to work automated alerts into their existing system.


What Improvement Would You Most like To Experience In Handling Edits To Collaborations On Contracts, Amendments, & Modifications?



21% said they need a more efficient way to update contracts with version control




33% said they're seeking a more organized change management process.

What Improvement Would You Most Like To Make For Managing Contract Approvals And Signatures?



- 9% -- We want to transform physical signatures and paper-based approvals to a digital solution.
- 24% -- We need a solution beyond approvals and eSignatures that rely on email communications only.
- 52% -- We are seeking a workflow-based approval system integrated with electronic signatures and digital signatures authentication.
- 13% -- We have no formal signing and approval process in place.


