#### **General**

- The ACC St. Louis Sponsorship Program term runs for the 2025 calendar year. The ACC St. Louis Board of Directors reserves the right, in its discretion, to modify the number of Sponsors within each Sponsorship level.
- Additional sponsorship opportunities: In the event ACC St. Louis identifies a new program or event
  that is outside the sponsorship offerings listed above, the Chapter will present the opportunity to
  existing sponsors with preference given to Platinum, Gold and, if still available, to Silver sponsors.
  If no existing sponsor expresses an interest in the opportunity, ACC St. Louis reserves the right to
  offer the opportunity to other non-sponsor organizations.
- ACC St. Louis does not guarantee attendance numbers for any program/event. The ACC strongly recommends each CLE program should include an in-house speaker/panelist. The sponsor for the program/event should work closely with Chapter representatives and adhere to Chapter guidelines and deadlines for each program/event. Sponsors are responsible for planning their event, along with ACC St. Louis. ACC St. Louis will provide a timeline for each event, including deadlines to submit topics, panelists, etc. Failure to adhere to the stated timeline may result in the cancelation of the event in the chapter's sole discretion. No sponsorship fees will be refunded in the event of a cancellation due to sponsor delay in submitting information. All event registration will be conducted through and by ACC St. Louis.
- Sponsors providing articles for submission to the ACC St. Louis newsletter must have topics approved by the Chapter prior to submission. The Chapter will provide the sponsor with a submission deadline for the sponsor's assigned newsletter; sponsor is responsible for timely submission of the article. No sponsorship fees will be refunded in the event a sponsor's article cannot be published as a result of sponsor delay in submitting its article.

#### Corporate Counsel Institute (CCI) on May 8, 2025

- In partnership with the Bar Association of Metropolitan St. Louis ("BAMSL"), ACC St. Louis hosts an annual all-day CLE program with topics devoted to in-house counsel. CCI has become one of the annual marquee events for in-house counsel in the St. Louis area. A social/networking opportunity follows the live CLE portion of CCI.
- CCI presentation slots may be either plenary or breakout sessions, as determined by the CCI Committee. The CCI presentation topics will be developed in coordination with the CCI Committee.
- Platinum Sponsorship, Gold Sponsorship, Silver Sponsorship and Resource Sponsorship includes an exhibitor table during CCI.
- Platinum sponsors may present a one-hour CLE at the CCI. Gold sponsors have the opportunity to present a one-hour CLE at either the CCI or the Golf Spa CLE (depending on availability).



#### 17th Annual ACC St. Louis Golf Spa and CLE

- In 2025, ACC St. Louis will host the 17th Annual Golf Spa CLE Event for its members. Held each year in the late summer or early fall, the day begins with a morning of CLE presented by Platinum and Gold sponsors, followed by an afternoon of golf or spa treatments. The event is extremely popular with Chapter members and provides assigned sponsors with an excellent opportunity to mingle with ACC St. Louis members and enjoy a round of golf or spa treatment.
- Platinum sponsors may present a one-hour CLE at Golf Spa CLE. Gold sponsors have the opportunity to present a one-hour CLE at either the CCI or the Golf Spa CLE (depending on availability).

#### **Diversity & Inclusion Sponsorship**

- Each year, ACC St. Louis hosts its Summer Diversity Internship Program through which the ACC St. Louis Diversity and Inclusion Committee selects students from Washington University School of Law, Saint Louis University School of Law, University of Missouri School of Law, and other law schools and pairs the interns with corporations in the greater St. Louis community for a summer internship. All interns participate in various educational, training, and social activities throughout the summer. In February, a panel of ACC-St. Louis Diversity and Inclusion Committee members interview candidates for these internships.
- The interns attend a Summer Intern Kick-off event in late May or early June to introduce interns to each other, their host company representatives, and their ACC assigned mentors.
- The Diversity & Inclusion Leadership Training committee hosts several events throughout the year where participants interact in a safe space and discuss topics that focus on diversity, inclusion and equity in our legal departments and the community.
- The Diversity & Inclusion Committee partners with area high schools for the Street Law Program to introduce students to the legal profession, and specifically in-house practice, as a future career path.

#### **PAN Sponsorship**

• The Practice Area Networking (PAN) sponsorship allows a law firm sponsor to increase the value of their sponsorship and reach a specific group of Chapter members and non-member in-house counsel who actively practice a specific area of the law. The PAN is expected to hold up to two (2) events each year, as virtual, casual lunches, or happy hour meetings, to provide networking opportunities with other in-house lawyers with similar practices, and at least one substantive presentation and discussion on the law. The PAN Sponsor will have an opportunity to provide a speaker or panel presentation for the substantive educational event. This format provides a unique and very focused opportunity for the sponsor law firm to highlight its practice group to Chapter members focused on the relevant area of the law. This sponsorship is a great add-on opportunity to enhance a regular sponsorship of the Chapter.



#### **Monthly CLE Programs**

- Gold sponsors have the opportunity to present a one-hour CLE at the Corporate Counsel Institute (CCI) or the Golf Spa CLE and one Monthly CLE program.
- Gold and Silver sponsors have the opportunity to present one monthly CLE devoted exclusively to
  issues facing in-house counsel. The format and location of the CLE is chosen by the sponsor (in
  consultation with the Chapter) and may be virtual or in person (over a breakfast or lunch, or after
  work with social/networking). The cost of the program is the responsibility of the sponsor. The
  monthly CLE provides Chapter sponsors with a great opportunity to spotlight an area of practice of
  the firm to Chapter members.
- In addition to exposure from the CLE presentation, sponsors are encouraged to allow the Chapter to post the presentation materials to the Chapter website for access by all Chapter members.
- Sponsors should develop CLE programs that are unique to the interests and needs of in-house counsel. Whenever possible, programs should include in-house attorneys as co-presenters or panelists. (ACC St. Louis can assist in this regard if requested and will provide program recommendations.)

#### **ACC St. Louis Newsletter**

ACC St. Louis will publish a monthly newsletter circulated to all ACC St. Louis members and
archived on the ACC St. Louis website. The newsletter format includes information on Chapter
events and programs as well as articles of interest to Chapter members. Select sponsor levels
include an opportunity for sponsors to publish a substantive legal article(s) of interest to in-house
counsel in one of the monthly editions. These articles provide our Sponsors with yet another
fantastic opportunity to highlight a law firm's area of practice with the Chapter's 650+ members.
