

Message From the Network Chair

First, my sincere thanks to the ACC Litigation Network leadership. Your dedication has made the Network a valuable resource for colleagues around the world. To everyone who has participated in our programs and events, thank you as well. If we haven't yet met, I hope you'll take a moment to introduce yourself at the conference.

Second, in light of recent events and the political turbulence that seems to define our time, I want to reaffirm the essential role lawyers play in addressing difficult problems with civility and reason.

Today's challenges are serious, but they are not greater than those our profession and society have faced before. Like Lincoln, I believe in the "better angels of our nature," and I remain confident that the rule of law will endure—provided we each do our part to sustain it.

Third, I encourage you to get involved in making things better, and to focus on the task—and art—of persuasion. Too often, our profession is thought of as centered on "arguing." In truth, persuasion is broader: it includes argument, but more often it is about patient explanation, careful teaching, and framing ideas with the listener's perspective in mind. "Teaching with a purpose" might be another way to describe what we do.

You can practice this art of persuasion at any level of community or government. As some of you know, I've been to Congress three times this year on an unusual subject: UFOs—or as they are now officially called, "Unidentified Anomalous Phenomena" (UAP). If conversations on a topic like that are possible, then so are yours on issues that matter to you. Our representatives do listen, but only if we take the time to express ourselves—civilly, thoughtfully, and with persuasion. It's easy to believe one person can't make a difference, but every change begins with a single person and a single idea. That person could be you.

Wishing you a strong close to summer 2025, and I look forward to seeing you at the Annual Conference.




