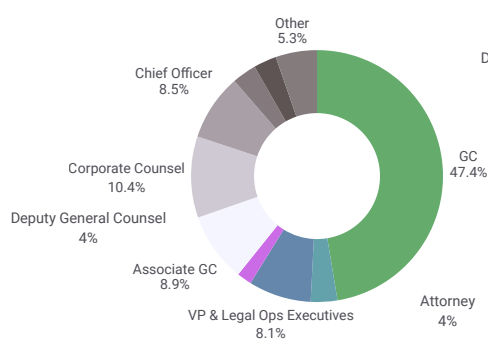

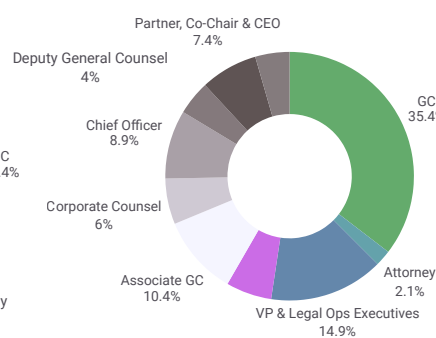
### ABOUT THE CONFERENCE

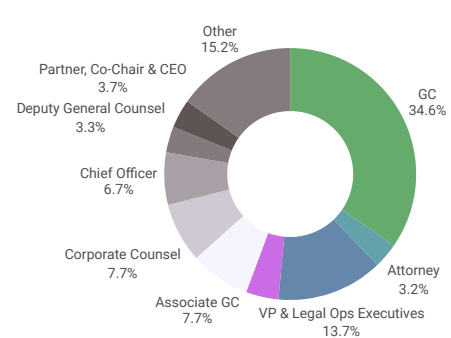
### PAST MEETING ATTENDEE DEMOGRAPHICS

Applicants may submit up to three (3) substantive Continuing Legal Education (CLE) proposals online by end January 2026. Selected programs must become Gold Level Sponsors to present their program.

## SILVER SPONSORSHIP - US\$33,200
