

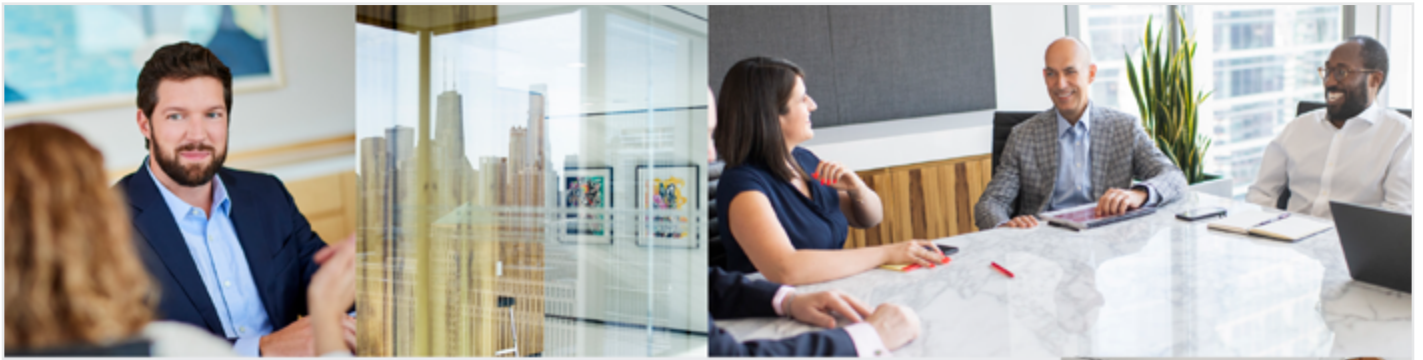

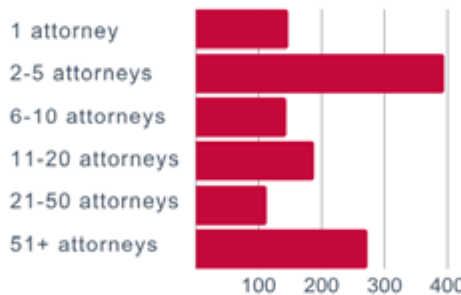

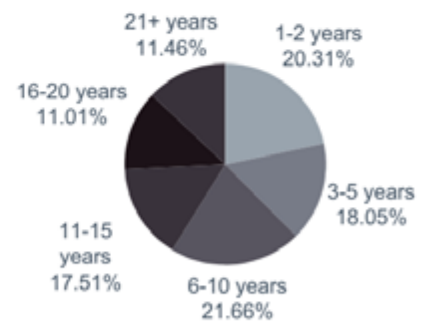

Number of Years In-House

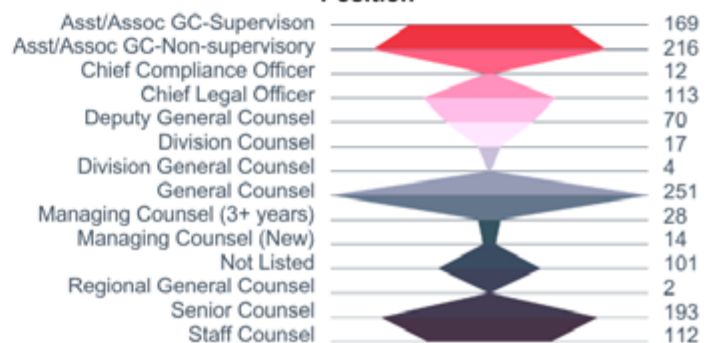
