Role of In-House Counsel in Litigation

- Strategic advisor and internal business partner
- Coordinates with executives, manages risk
- Supervises outside counsel and internal discovery
- Ensures compliance with ethical duties
- CRPC Rules: 1.1 (Competence), 5.1 (Supervision)



Working with Outside Counsel – In-House Counsel Responsibilities

- Provide clear objectives, business context, and success criteria
- Define scope, deliverables, and escalation paths earl
- Share internal constraints (budgets, comms protocols)
- Offer prompt feedback and approvals to avoid delays



Working with In-House Counsel – Outside Counsel Best Practices

- CRPC 2.1 —Independent judgment and candid advice
- CRPC 1.2 —Client decides objectives; lawyer assists with legal means
 - Learn the client's business and tailor advice accordingly
 - Be proactive: flag risks, budget overages, strategic shifts early
 - Understand how the litigation fits into the client's business strategy
 - Avoid surprises



Budgeting & Cost Control

For In-House Counsel

- Use phased budgets and AFAs where possible
- Require regular financial updates with variance explanations
- Track matter performance using KPIs

For Outside Counsel

- Submit realistic budgets with clear assumptions
- Communicate promptly about deviations
- Collaborate on creative fee structures (flat fees, success fees)
- Avoid "overlawyering"



Managing Internal Expectations

In-House Counsel

- Translate litigation risk to business impact
- Provide timely updates
- Balance confidentiality with transparency

Outside Counsel

- Help frame litigation events and outcomes for executives
- Keep in-house counsel well-informed
- Anticipate possible outcomes of motions/trials



Reporting to Executives

- Highlight business impact
- Summarize status, next steps, risk, and cost
- Outside counsel can support
- Use visual tools if helpful (dashboards, charts)



Settlement vs. Trial Strategy

- Involve stakeholders early in risk-benefit analysis
- Evaluate reputational, financial, and operational costs
- Outside Counsel should make sure to document advice
- Avoid emotional decision-making



Partnership Best Practices

- ✓ Treat each other as strategic partners
- ✓ Align on goals, not just tactics
- ✓ Use clear and consistent communication
- ✓ Trust and respect are critical
- Collaborate on cost and case management
