# The Lanham Act and its Extraterritorial Reach

The Lanham Act (15 U.S.C. §1051) is the primary vehicle in the United States for protecting trademarks and copyrights. However, as technology makes the world smaller companies based in the United States must decide how to protect their valuable trademarks and copyrights in the global market. There are two primary approaches that can be taken to protect the product of a United States corporation in the global market. The first approach is to register your

company's mark and/or copyright in each individual country in which your product may become available, or in which your company's product may be counterfeited. This can be overwhelming as there are so many countries, with their own unique registration process. The second approach is to utilize United States law to protect your trademarks and copyrights in the global market. Although the jurisdiction of the United States Federal Courts are limited, the Federal Courts will allow jurisdiction of some primarily extraterritorial disputes when a United States trademark or copyright is exploited outside of the United States.
