Legal Services of Eastern Missouri is an independent, non-profit organization that provides high quality civil legal assistance and equal access to justice for low-income people and the elderly in eastern Missouri. LSEM is a tax exempt 501 (c) (3) corporation.

Areas of practice include family law (serving survivors of domestic violence); guardianships and related tools; housing; immigration; public benefits; educational justice; health care and health insurance; consumer law; estate planning; community economic development; mental health law.

Who Does the Legal Services Corporation Help?

- LSC-funded programs help people who live in households with annual incomes at or below 125% of the federal poverty guidelines –
- In 2018, that was \$15,175 (\$12,140) for an individual, \$31,375 (\$25,100) for a family of four.
- More than 60 million Americans have family incomes at or below 125% of FPL, including:

About 6.4 million seniors
More than 11.1 million persons with disabilities
More than 1.7 million veterans
About 10 million rural residents

• "Pro bono publico" is Latin, meaning literally for the public good. The phrase "pro bono" refers today to legal work undertaken voluntarily and without payment.

Is Pro Bono An Ethical Obligation?

ABA Model Rules of Professional Conduct. Rule 6.1 Voluntary Pro Bono Publico Service:

Every lawyer has a professional responsibility to provide legal services to those unable to pay. A lawyer should aspire to render at least (50) hours of pro bono publico legal services per year.

State Rules of Professional Conduct: Voluntary Pro Bono Service:

U.S. jurisdictions vary in their adoption of the ABA Model Rule 6.1. Nearly half of all U.S. jurisdictions set a specific annual goal of 50 hours while most of the others set no specific goal. The handful of jurisdictions that do not fall into either of those two categories set a different specific annual goal, such as 20 hours, or use a formula to determine the goal, considering various factors.

Limited Scope Representation

- Consent
 - Assessment of client
 - Client understanding of implications of limited scope representation
 - Written agreement
- Types of Projects
 - Advising clients on procedural and strategic aspects of a pending case
 - Assisting clients in completing forms
 - Preparing and drafting court documents
 - Coaching clients on how to present in court
 - Providing clients brief advice and counsel
 - Appearing in court for limited purposes

Missouri Rules of Professional Conduct. Rule 4-1.2 Scope Of Representation:

(c) A lawyer may limit the scope of the representation if the limitation is reasonable under the circumstances and the client gives informed consent in a writing signed by the client to the essential terms of the representation and the lawyer's limited role.

Sample Interactive Exercise

You have recently taken a legal aid/pro bono case. After an initial phone introduction, your new client, Lisa, agrees to come to your downtown office for an in-person meeting to talk about her case. You prepare for the meeting, move your other commitments around, and on the day of the meeting, Lisa neither calls nor keeps the appointment.

Why might Lisa neither have kept her appointment nor called?

- Out of minutes on her phone
- Lost your contact information and does not have an iphone in which to store it
- Intimidated by the office building and surroundings
- No ID to enter building
- Reluctant to move forward with a legal proceeding especially in domestic violence situations
- Victim of a crime since you last spoke with her
- In jail
- Lack of child care
- Feared losing her job or facing discipline if she took off from work
- Got called into work unexpectedly
- Lack of transportation; her ride didn't show up, missed her bus or train, no funds for fare

Benefits to Legal Services of Eastern MO Volunteers

- Legal Services provides primary malpractice insurance coverage to all of our volunteers, at no charge
- Legal Services handles client intake and performs a client eligibility assessment
- Legal Services identifies cases and clients that are appropriate for placement with volunteers
- Legal Services provides free training through accredited legal education seminars
- Volunteers have access to staff attorneys for answers to substantive questions
- Legal Services will step in if a volunteer attorney has to withdraw or otherwise cease representation

How the Volunteer Lawyers Program Works

- Referral Model
 - LSEM screens
 - Priorities
 - Conflicts
 - Financial eligibility
- Volunteer Acceptance
- Support
 - Before Trainings, Screening, case file development
 - During Certificate of Inability to Pay, Pleadings, Questions, Difficult Clients, Eligibility
 - After Feedback, Address concerns
